Meeting Called to Order

President Jane Martin called the meeting to order at 7:02 PM on June 8, 2011. Julie Grothues was appointed as Parliamentarian, Hugo DuBois was designated as Sergeant at Arms, and the agenda was adopted as the Orders of the Day. There were no objections.

Homeowner Forum

Homeowners asked questions about the status of the lawsuit. It was explained that the lawsuit had been settled, as previously announced, and that the Board was in the process of distributing the settlement IFCIA received to the IF homeowners. It was noted that the settlement IFCIA received was less than the total amount spent on the lawsuit. Grothues noted that a letter will be sent with the settlement distribution checks explaining how the distribution was calculated etc... Approval of Minutes

Emerson moved to accept as presented the May 11, 2011 meeting minutes. Tom Haynes seconded and it was passed unanimously.

Financial Reports

Management Reports

A. Properties and Facilities Committee Report

Grothues reported that Poli DeLeon and his crew completed the tilling of the volleyball court and more sand will be added to help reduce the maintenance of the court. Minor repairs were completed at the pool and the two esplanades that IFCIA has temporarily adopted on Antoine south of IF have only been mowed once to date.

B. Deed Restrictions Committee Report

Pierce reported that 284 violation letters were sent out and 337 were cured this month. He noted that there was a noticeable increase in the number of un-mowed yards and fences that need repairs, as well as an increase in mildew on houses.

C. ACC Committee Report

Emerson reported that several applications were submitted, one on Green Lawn for a Hardi plank replacement, one on Green Terrace for a replacement patio cover and several for painting. Some are still being reviewed by the committee at this time.

D. Security Committee Report

Ward reported that during the month of May, crime outside the IF community increased and that there were 4 burglaries inside the IF community.
