

INWOOD FOREST 2017 POOL SEASON INFORMATION

Summertime is almost here and that means it's time to register for the pool. Registration is open to all Inwood Forest residents who are **members in good standing** (those members who have paid their 2017 maintenance dues **or** are current on an approved payment plan and do not have any dues outstanding from a previous year(s).) Here is what you need to do to make sure that your family will be able to participate in the summer fun:

1. Complete the 2017 pool application on the back of this form.
2. Bring the **completed** application **and a photo ID** to the **POOL**. **Registration will take place at the pool on Saturday, June 3rd and Sunday, June 4th during regular pool hours.** (See pool hours below.) If a volunteer is not there when you are, please leave your completed application with the lifeguards and we will contact you.

Acceptable forms of ID include:

- A photo ID such as a driver's license that includes your correct Inwood Forest address
- A photo ID and a current bill that shows your name and current Inwood Forest address
- If you are new to Inwood Forest, you will need to bring your deed of sale, which will show that your account has been paid for the year.

Badges will be issued to each family member age 12 and over. **A fee of \$2 per badge will be charged to cover the cost of the badge.** Children under the age of 12 will not be issued badges. They will, however, be required to sign in when they visit the pool and will be required to be accompanied by an Inwood Forest resident age 18 or over who has a pool badge.

Pool badges must be picked up by an adult age 18 years old or older in your household at the above times unless prior arrangements have been made. Badges will be issued to homeowners and their children who reside at the residence. Extended families will not be issued badges and must be accompanied by the homeowner as guests.

Renters - If you are a renter, please ensure that the owner has paid the yearly maintenance dues. Also, if the owner chooses to receive the pool badges, we will be unable to issue them to you.
