2025 Inwood Forest Pool Rules

Children under 14 years of age must be accompanied by an adult in the pool area.

All swimmers must be registered and wearing pool wrist bands.

All guests must be accompanied by a registered member.

BATHING SUITS ONLY IN THE POOL. The only exception is white T shirts that can be worn over your bathing suit. NO OTHER CLOTHING CAN BE WORN IN THE POOL.

Swim diapers are required on children age 3 and under at all times.

No talking with the lifeguard while on the stand.

No running or excessive horseplay.

No profanity.

No glass items in the pool or pool area.

No food, drink or gum in the pool.

No alcohol.

No Smoking.

No pets in the pool area.

Music systems (radios, CD's, cell phones etc) are permitted only with the use of headphones/earbuds.

No artificial spray-on temporary hair color chemicals are allowed in the pool.

Pool Opening Dates and Hours of Operation

The pool will be open for the summer on Saturday, May 24th. Summer hours of operation will be:

MondayClosedTuesday - Friday3 p.m. to 8 p.m.Saturday - Sunday1 p.m. to 8 p.m.

Guests

Registered residents age 18 years old and older may bring up to 2 guests per household at no charge. Any additional guest(s) will need to purchase a Non-Resident Day Pass. See below.

Parties at the Inwood Forest Park and Pool

The Inwood Forest pool and pavilion are available for parties to Inwood Forest residents.

Pool Parties – Pool parties are to be held <u>before</u> regular pool operating hours when the pool is closed. All pool parties must be arranged through the TAE Pools. See the message center number below or email the board at board@ifciaboard.com.

Pool party requirements:

- 1 lifeguard per every twenty people inside the gated area with a minimum of 2 lifeguards per party.
- •\$25 per hour per lifeguard paid in money order only the day of the party with a 2 hour minimum.
- Pool parties will not be held on holiday weekends such as 4th of July and Labor Day.

Inwood Forest requires that residents pay a \$500 refundable deposit at the time the party is booked. The deposit will be returned if the pool and pavilion area is clean and there is no damage to any park or pool property.
