

2026 Inwood Forest Pool Rules

Children under 14 years of age must be accompanied by an adult in the pool area.

All swimmers must be registered and must comply with pool registration and access requirements

A registered member must accompany all guests.

Appropriate swim attire is required in the pool. Clean swim shirts or rash guards designed for aquatic use are permitted.

Swim diapers are required on children age 3 and under at all times.

No talking with the lifeguard while on the stand.

No running or excessive horseplay.

Disruptive, abusive, or inappropriate conduct is prohibited.

No glass items in the pool or pool area.

No food, drink, or gum in the pool.

No alcohol is permitted on IFCIA property.

No Smoking or vaping products are permitted in the pool area.

No pets are permitted in the pool area.

Music systems (radios, CD's, cell phones etc.) are permitted only with the use of headphones/earbuds.

No artificial spray-on temporary hair color chemicals are allowed in the pool.

Pool Opening Dates and Hours of Operation

The pool will be open for the summer on Saturday, May 23rd. Summer hours of operation will be:

Monday	Closed
Tuesday – Friday	3 p.m. to 8 p.m.
Saturday - Sunday	1 p.m. to 8 p.m.

Guests

Registered residents aged 18 years old and older may bring up to 2 guests per household at no charge. Any additional guest(s) will need to purchase a Non-Resident Day Pass. See below.

***Non-resident payment must be received prior to card issuance through cashiers check or money order ONLY. Resident Day Use passes must be paid online via the resident portal.**

Parties at the Inwood Forest Park and Pool

The Inwood Forest pool and pavilion are available for parties hosted by Inwood Forest residents.

Pool Parties – Pool parties may only be scheduled outside of regular pool operating hours while the pool is closed to general use, except on cleaning days. All pool party reservations must be arranged through TAE Pools at www.taepools.com. Any required deposit must be paid to Inwood Forest by cashier's check prior to amenity access being granted. Please contact Sharrell.drawsand@inframark.com to arrange payment.

Pool party requirements:

- One (1) lifeguard per every twenty (20) people inside the gated area with a minimum of two (2) lifeguards per party.
- Pool parties will not be scheduled on holiday weekends, including Memorial Day, Fourth of July, and Labor Day weekends.

Inwood Forest requires that residents pay a \$300 refundable deposit at least 2 weeks prior to the party date. The deposit will be returned within 30 days upon inspection of the pool and pavilion area. Once confirmation is received by Management that the area is clean and there is no damage to any park or pool property, the refund will be sent.
